**Victim's Journey**



**Case Manager**

- Mails out your Victims' Rights Packet
- Calls you to introduce CAFY
- Schedule Intake Appointment
- Assesses your Needs
- **Long-term Case Manager is assigned**



**Case Manager**

- Calls or meets with you to begin the journey to healing and re-stabilization
- Provides on-going support through the range of services CAFY and other providers offer

**Case Management**

Your advocate reviews Victims' Rights Info Packet with you

Helps you to complete the Criminal Injury Compensation Board (CICB)

Discusses CAFY Services with you to determine what solutions suit your needs

Helps you to complete the Victim Information Notification Everyday (VINE)

Trauma Support  
Your advocate discusses the different referral solutions available

Provides Support and Encouragement  
*'We are here for you'*



**Court Education**

You are scheduled for Court Education Program (CEP)

You receive confirmation of class approx 7 days prior to date

You get a reminder phone call 2 days prior to class

You attend CEP

Your advocate prepares you to manage anxiety as a result of victimization

Discuss counseling

Prepares you to be an effective witness during a mock trial  
*Judge and Asst. State Attorney are present*



**Court Companionship**

An advocate provides morale support in court proceedings to you and your children

**Individual Therapy & Support Group**

Trauma-Focused individual crisis therapy

You attend a 6-week LIFE module session focused on Healing
